21/AS/19/UEPC General Education (GE) Area and Outcome Alignment (Revised)

RESOLVED: That 01/AS/19/UEPC – General Education (GE) Area and Outcome Alignment Revised Fall 2018 be revised to include a footnote to area E, indicating that the one-unit, physical education activities courses in Area E (KINS 1010-1999) are only expected to address GE Outcome 2.6, rather than 2-4 GE Outcomes:

• Footnote text: "One-unit physical education activities courses (KINS 1010-1999) are only expected to address Outcome 2.6, rather than 2-4 Outcomes."; and be it further,

RESOLVED: This policy only applies to KINS 1010-1999 courses.

RESOLVED: The entirely physical focus of Physical Education Activities courses makes them a valuable contrast to the generally intellectual focus of most General Education courses. General Education courses are now all required to address 2-4 GE Outcomes. However, the physical focus of KINS activity classes makes addressing entirely intellectual GE Outcomes difficult. Outcome 2.6 requires a course to "address life-skills and behaviors needed to flourish as a mature person," which is one of the two anchor options for Area E, and the one most appropriate to these KINS courses. To preserve the valuable contribution Physical Education Activities courses can make to our students' lifelong health, GE Sub and UEPC supports this policy revision.

14/AS/18/UEPC/GE – General Education (GE) Breadth and Multicultural Requirements indicates that the Area E requirement "may not be satisfied entirely through Physical Education Activities courses (KINS 1010-1999)." Because students will be required to have at least part of their Area E requirement satisfied by a course that does address 2-4 of the General Education outcomes, allowing the one-unit KINS courses to only address one outcome will not undermine the integrity of the Area E requirement.
