WHEREAS: General Education Areas require Goals and Outcome Alignment per [17/AS/14/UEPC](#).

WHEREAS: UEPC, GE-Sub, and the Ad-Hoc Committee on the Implementation of the Ethnic Studies Requirement have agreed upon Goals (2, 3), an Anchor Outcome (2.3), and two Suggested Outcomes (3.3, 3.4) for Area F.

WHEREAS: Per [10/AS/21/UEPC](#), “the UEPC and GE-sub committees, in collaboration with the Ad-Hoc Committee on the implementation of the Ethnic Studies requirement, [have worked] to develop a structure for ongoing review and assessment of Area F courses, including addition of courses to area F and integration with existing curricular approval structures,” be it

RESOLVED: That the California State University Stanislaus Academic Senate recommends the attached revision to the General Education Area and Outcome Alignment previously adopted under [21/AS/19/UEPC](#), and be it further
